on the placing on the market of pyrotechnic articles

# Directive 2007/23/EC of 23 May 2007

will be repealed as from 1 July 2015 by the recast Directive 2013/29/EU of 12 June 2013 on the harmonisation of the laws of the Members States relating to the making available on the market of pyrotechnic articles.

By way of derogation, point 4 of Annex I has been already repealed from 4 July 2013 and replaced by point 4 of Annex I under the new Directive 2013/29/EU.



#### Main objectives

To establish a single market in the EU in trade of pyrotechnic articles

To ensure a high level of consumer and environmental protection through harmonised safety requirements, and the setting up of a traceability system for pyrotechnic articles



# Main provisions

- Scope
- Definitions

- Categorisation of articles according to type of use or purpose and level of hazard: fireworks, theatrical pyrotechnic articles, other pyrotechnic articles (e.g. air bags)

- Obligations of economic operators
- Essential safety requirements



# Main provisions, cont.

- Free movement of goods
- Age limits and labelling requirements
- Harmonised standards
- Conformity assessment and notified bodies
- CE marking
- Market surveillance, rapid information exchange, safeguard clause, penalties, etc.



### Main provisions, cont.

Annex I – Essential safety requirements Annex II – Conformity assessment procedures (Modules B, C, D, E, G, H Annex III - Qualifying criteria for notified bodies Annex IV – CE marking



#### **Transposition and implementation**

*Transposition deadline was 4 January 2010. Application of Directive by Member States: 4 July 2010 for cat. 1 – 3 fireworks and 4 July 2013 for all other pyrotechnic articles. Transitional provisions until 2017.* 

Development of harmonised standards. So far EN 15947, EN ISO 14451, EN 16256 and EN 16261 (EU Official Journal C 136 of 15 May 2013)

#### **Transposition and implementation**

Implementing Directive 2014/58/EU of 16 April 2014 setting up a system for the traceability of pyrotechnic articles

Member States shall adopt and publish by 30 April 2015 the provisions necessary to comply with this Directive and shall apply those provisions as from 17 October 2016.
